You are entitled to receive this Good Faith Estimate of your potential charges for psychotherapy services provided to you. While it is not possible for a psychotherapist to know, in advance, how many psychotherapy sessions may be necessary or appropriate for a given person, this form provides an estimate of the cost of services provided. Your total cost of services will depend upon the number of psychotherapy sessions you attend, your individual circumstances, and the type and amount of services that are provided to you. This estimate is not a contract and does not obligate you to obtain any services from the provider(s) listed, nor does it include any services rendered to you that are not identified here. This good faith estimate is valid for 12 months.

This Good Faith Estimate is not intended to serve as a recommendation for treatment or a prediction that you may need to attend a specified number of psychotherapy visits. The number of visits that are appropriate in your case, and the estimated cost for those services, depends on your needs and what you agree to in consultation with your therapist. You are entitled to disagree with any recommendations made to you concerning your treatment and you may discontinue treatment at any time.

The fee for a 30 - 45 minute psychotherapy visit (in person or via telehealth) is from \$125.00 to \$160.00 per session and will be determined in the initial intake session and revised as needed. Most clients will attend one psychotherapy visit per week, but the frequency of psychotherapy visits that are appropriate in your case may be more or less than once per week, depending upon your needs or desires. Based on a fee of \$125.00 to \$160.00 per visit, the following are expected charges of psychotherapy services for 1 session or 2 sessions per week. In some cases the client's treatment plan may include more than 2 sessions per week, and the client and the clinician will discuss those options if needed and an estimate can be provided upon request. For certain services, pre-paid packages are provided and the current rates are published on the website, <a href="www.authenticbrainsolutions.com">www.authenticbrainsolutions.com</a>. These package purchases may not fulfill the entire treatment plan and additional estimated charges are based on the estimates below or as outlined in the then current prepaid package pricing.

If you choose to utilize this dispute option, you will be required to submit your claim within 120 calendar days from the date of your first bill. There is a \$25 fee to utilize the HHS dispute process. If the agency reviewing your claims agrees with you, you will have to pay the price of the good faith estimate. If the agency disagrees with you and agrees with your health care provider, you will be required to pay the full amount.
